## **DAILY SITUATION UPDATE**

Somalia, August 21, 2023

In an effort to combat the extremist group Al-Shabaab, President Hassan Sheikh held meetings in Dhusamareb with the objective of involving the local population. The purpose was to accelerate the implementation of plans for the initial phase of the operation. This highlights the government's commitment to addressing the issue of extremism in the country.

Meanwhile, Hargeisa's Mayor, Abdikarin Ahmed Mooge, denied claims of joining Somaliland's ruling party, Kulmiye. Mooge emphasized his dedication to his elected responsibilities, indicating a focus on local governance and serving the interests of the community.

In Puntland, former lawmakers expressed their discontent with the regional constitutional court, accusing it of causing delays in their case regarding their alleged unlawful expulsion from parliament in 2020. This highlights concerns regarding the judiciary's perceived impartiality and its impact on political processes.

Bilal Bulshawi, a prominent figure on TikTok in Somalia, openly defied the government's ban on the platform. Bulshawi argued for comparable treatment as other social media platforms and highlighted the positive contributions of TikTok. This demonstrates the ongoing debate surrounding freedom of expression and the regulation of social media in the country.

Tensions continued to escalate in LasAnod as clashes between local fighters from SSC-Khaatumo state and the Somaliland army resulted in civilian casualties and displacement. The situation reflects the ongoing conflicts and disputes between different regions and factions within Somalia.

In Somaliland, the ruling Kulmiye party selected President Muse Bihi as their candidate for the upcoming presidential election, highlighting the party's support for his leadership. Additionally, Mohamed Kahin Ahmed was appointed as the new chairman, potentially positioning him as President Bihi's successor. These developments signal political manoeuvring and succession planning within the ruling party.

Ali S. Aweys expressed doubts about the ongoing anti-corruption trials in Mogadishu, questioning the government's commitment to combating corruption. Aweys raised concerns about biased investigations and the lack of an independent judiciary, indicating challenges in the country's anti-corruption efforts.

August 21, 2023, witnessed significant progress by the Somali National Army against Al-Shabaab. They regained control of several villages in the Galgaduud region of Galmudug state. The operation aimed to improve safety for local residents by removing mines and dislodging Al-Shabaab from the region. Elbur district, although still an Al-Shabaab stronghold, was

effectively encircled, marking a significant step toward eliminating the group's presence in Somalia.

The government's strategy, initiated in August 2022, involved supporting local clans in the central regions of Hirshabelle and Galmudug. This resulted in the expulsion of Al-Shabaab from long-held areas and paved the way for subsequent military campaigns. The collaborative efforts of the Somali National Army and local community forces contributed to the successful recapture of the strategic town of Wabxo in the Galgadud Region.

However, incidents of violence and unrest also occurred. A protest in Beledweyne town turned violent, resulting in casualties, highlighting the challenges faced in maintaining stability during times of civil discontent. An altercation between two Somali soldiers took place in Mogadishu, leading to injuries, indicating internal conflicts within the security forces. A fire set by the group Cabtoy at the KM4 bridge in Mogadishu raised concerns for public safety, emphasizing the need for effective law enforcement and measures against criminal activities.

Furthermore, a suspected explosive device near the National Hospital led to a road closure while the police bomb squad investigated the situation. This incident underscores the ongoing security threats and the need for vigilance in countering potential terrorist activities.

Efforts to address a denial-of-service attack against the website of SJS Somalia were initiated, highlighting the importance of cybersecurity in protecting critical information and media outlets. Investigations into an improvised explosive device (IED) explosion targeting the residence of Commander Sheegow Ahmed in Beelahaar, Jayren, were also underway, highlighting the persistent threat of violence from extremist elements.

Lastly, the transfer of responsibility for the Force Protection Unit of the European Union Training Mission in Somalia showcased the commitment to maintaining safety and security in the country, with international support and cooperation.

The 19th "Linci" Company concluded their tenure, and the 1st "Cobra" Company took over responsibilities, emphasising the commitment to the mission's safety and security.

### Politics

On August 21, 2023, **President Hassan Sheikh of Somalia conducted a series of meetings in Dhusamareb city as part of efforts to engage the local population in the fight against Al-Shabaab.** During these discussions, the president met with traditional elders, politicians, and representatives from the Galmudug state, led by regional leader Ahmed Abdi Karie Qor-Qor. The primary purpose of these meetings, as conveyed by Villa Somalia, was to expedite the implementation of plans for the initial phase of the operation against Al-Shabaab. President Hassan Sheikh urged attendees to collaborate closely with the government in reclaiming the remaining areas under Al-Shabaab control in Galmudug. Concurrently, government forces, alongside American troops, and local fighters, were advancing toward



key Al-Shabaab strongholds, including Elbur and Galhareri towns, both located in Galmudug. The president's presence in Dhusamareb over the past weeks has significantly boosted the morale of the troops and the local community involved in the fight against Al-Shabaab.

August 21, 2023, **Hargeisa's Mayor, Abdikarin Ahmed Mooge, denied joining Somaliland's ruling party, Kulmiye, refuting the claims made by the party on three separate occasions.** In an interview with Galaydh Media at Hargeisa's Freedom Park, Mooge categorically dismissed the allegations, asserting that he had no affiliation with Kulmiye or any other party. While he previously belonged to the opposition party, Waddani, Mooge clarified that he had not joined any party after leaving Waddani. He expressed his unwavering commitment to serving the responsibilities for which he was elected by the people of Hargeisa. Known for his strong stance against tribalism, Mooge secured a significant electoral victory in the regional councillors' election on May 31, 2021, and has since emphasized his dedication to upholding his commitments and acting as a mediator in political disputes within Somaliland.

August 21, 2023, **former lawmakers of Puntland expressed their dissatisfaction with the regional constitutional court, blaming it for the prolonged delay in reaching a decision on a case they had filed four months earlier.** The lawmakers, speaking in Garowe, alleged that their expulsion from the parliament in 2020 had been conducted unlawfully and urged the court to intervene and challenge the procedures resulting in their removal. They further claimed that the court's chairman was facing external pressure, which hindered his ability to handle their case impartially. The parliament had revoked the membership of eight lawmakers in December 2020 for allegedly violating parliamentary rules, a decision that was ultimately backed by the Puntland High Court. Subsequently, these expelled lawmakers were replaced by others selected by their respective tribes. The former MPs have continuously asserted that their removal was primarily driven by their opposition to Puntland's regional President, Said Abdullahi Deni, and have since been engaged in a legal battle to contest their expulsion.

August 21, 2023, **Bilal Bulshawi, a prominent TikTok personality in Somalia, openly defied the government's forthcoming ban on the popular social media platform.** In an interview, Bulshawi argued that TikTok should be treated similarly to other platforms like Facebook and YouTube, as content from TikTok often finds its way onto these platforms. He criticized the government's decision, stating that it was based on market considerations rather than an evaluation of TikTok's societal impact. Bulshawi emphasized the benefits of TikTok, such as its potential as a source of income and employment for young people, and highlighted its positive contributions in drought-affected regions through initiatives like food donations. He expressed his belief that the government's ability to enforce the ban is limited and boldly declared his intention to continue using TikTok regardless. Bulshawi's defiance has sparked a broader debate on social media regulation and freedom of expression in Somalia, raising questions about the effectiveness of the government's decision. The ban on TikTok takes place amid a global discussion surrounding the platform's influence, security concerns, and societal impact, with different countries adopting varying stances. With voices like Bulshawi's emerging, the ban on TikTok is likely to remain a contentious issue in the coming weeks.

August 21, 2023, **Somaliland's ruling party, Kulmiye, conducted an internal leadership selection process ahead of the upcoming elections.** The party gathered in Burao to determine key leadership positions, including the selection of a presidential candidate and the appointment of a chairman. President Muse Bihi was endorsed by Kulmiye as their chosen candidate for the forthcoming presidential election, seeking re-election for a second term after his initial victory in 2017. The party also named Mohamed Kahin Ahmed, the nation's interior minister, as their chairman. The position of deputy chairman was secured by Abdiaziz Mohamed Samaale after a competitive electoral process, defeating Mohamed Elmi Adan. Notably, several positions within the party remained uncontested, lacking rival candidates. The electoral schedule outlined by Kulmiye has yet to receive endorsement from opposition parties.

On August 21, 2023, **tensions in the northern city of LasAnod continued as local fighters from the SSC-Khaatumo state attempted to confront the attacks launched by the Somaliland army from nearby Gooja-Ade.** The city mourned the loss of Jama Kediye Elmi, a prominent poet and advocate for self-determination in the Sool, Sanaag, and Cayn regions. Mohamed Hajji Hussein, a former mayor of LasAnod, expressed the SSC-Khaatumo state's reluctance to negotiate with Somaliland as long as it occupied even a small portion of their territory. Hussein further accused Somaliland troops of committing genocide within LasAnod by indiscriminately bombing civilian areas, including schools, mosques, and hospitals. The ongoing conflict, which began in February 2023, has resulted in the death of hundreds of civilians and the injury of thousands more. Many families have sought refuge by crossing the border into Ethiopia. Both the United Nations and the United States have urged for calm and peaceful dialogue, emphasizing the need to avoid excessive use of force. LasAnod has been a hotbed of conflict between Puntland and Somaliland, with the latter having governed the city since 2007. The local population aspires to gain independence from both states and establish their own autonomous administration.

On August 21, 2023, **the ruling Kulmiye party in Somaliland elected Mohamed Kahin Ahmed as its new chairman during a party convention held in the capital city of Hargeisa.** Ahmed, a long-serving politician, and the current interior minister, replaces President Muse Bihi in this role. The selection of Ahmed as chairman positions him as a potential successor to Bihi, who praised him as the "most worthy candidate" for the party's leadership. Meanwhile, Bihi himself was chosen to be the party's flag bearer in the upcoming December 2024 elections. Alongside Ahmed, Mohamud Hassan Saajin was elected as the vice chairman of the party. It's noteworthy that Bihi's term, which was originally set to end in November 2023, was extended by two years last October by the House of Elders (Guurti).

On August 21, 2023, **Ali S. Aweys authored an article expressing skepticism about the ongoing anti-corruption show trials in Mogadishu, Somalia.** According to Aweys, these trials are intended to deceive the international community into believing that the Somali government, led by President Hassan Sheikh Mohamud, is committed to combating corruption. Aweys questions the credibility of President Mohamud's anti-corruption rhetoric, considering his family's business interests in Mogadishu. Aweys highlights the history of unlawful land occupation and looting in Mogadishu since 1991, with powerful local



clans confiscating public and private properties. The article criticizes the composition of the national assets committee responsible for these trials, suggesting biases due to clan affiliations. The author cites a journalist who compares the involvement of corrupt individuals in the judiciary to an extension of injustice. Aweys also discusses dubious investigations into a government worker's bank account and raises concerns about the government potentially planting evidence in bank accounts to frame critics. The author contends that the absence of an independent judiciary in the country makes it incapable of properly investigating corruption. President Mohamud's attempts to condemn corruption in his speeches are seen as a political strategy, rather than a genuine commitment to combatting corruption. Aweys emphasizes that leaders should declare their assets and avoid conflict of interest, particularly when family members benefit from public office. The article argues for the need to cleanse Somali politics of former businesspeople and politicians with commercial interests, as corruption continues to thrive under the pretence of anti-corruption efforts. However, the author concludes by asserting that the international donors will not be deceived by the Somali government's diversionary tactics.

## Security

On August 21, 2023, **the Somali National Army successfully regained control of several villages in the Galgadud region of Galmudug state, namely Jaw, Dadale, Habarcirir, and Xilin-Fardood.** This military operation aimed to dislodge the extremist group Al-Shabaab from the region. The defense ministry stated that the troops cleared the areas of mines, improving the safety of passages for local residents. Elbur district in Galgadud now remains as one of the few remaining strongholds of Al-Shabaab, with the national army having encircled it. This marks a significant step in the ongoing efforts to combat and eliminate Al-Shabaab's presence in Somalia. The government's strategy, initiated in August 2022, involved a concentrated offensive against Al-Shabaab, supporting rebellious local clans in the central regions of Hirshabelle and Galmudug. These operations led to the expulsion of Al-Shabaab from long-held areas and paved the way for subsequent military campaigns.

August 21, 2023, **the National Army, with the support of local community forces, successfully recaptured the strategic town of Wabxo in the Galgaduud Region.** Security operations, including the removal of mines and other hazards, are currently underway to ensure the safety of the town's residents. In addition, the National Army and local forces have extended their operations to nearby areas in a coordinated approach to counter potential threats and establish lasting security throughout the region.

August 21, 2023, **the Somali National Army (SNA) and local forces known as Macawisley made notable advancements in the Galgadud region, which is under the administration of Galmudug State.** The military officials present at the frontlines reported that the SNA Chief, Ibrahim Muhyadin, and international partners were also present in the region to support and encourage the forces in their ongoing offensive operation against the extremist group Al-Shabaab. The Somali National Army successfully gained control over several key areas, including Jaw, Dadale, Habarcirir, and Xilin-Fardood, thus expanding their presence in the region. As part of their efforts, the SNA demined roads and forest areas,

enhancing the safety of travel for civilians. The Ministry of Defence emphasized their continued determination by stating, "Elbur, we have you in our sights. We converge from all directions." This advance by the Somali National Army marks a significant step towards countering the influence of Al-Shabaab in the Galgaduud region.

On August 21, 2023, **the Somali National Army (SNA) reportedly gained control of Wabho, a strategically significant town located between Mahaas and El Buur in Galgaduud, Somalia.** However, the history of control in this area reveals a pattern of temporary victories and quick losses, raising concerns about the government's ability to maintain long-term control. Wabho has witnessed multiple shifts in control since 2014, with various forces gaining and then relinquishing it to al-Shabaab. The town's importance underscores the need for a sustainable strategy that extends beyond military successes, involving elements such as strategic planning, strong governance, infrastructure investment, and social development programs to build trust within the community. Achieving enduring stability in Wabho and the broader Galgaduud region requires learning from past experiences and implementing a cohesive and long-term plan.

August 21, 2023, **a protest took place in Beledweyne town, leading to one fatality and two injuries as security forces opened fire on demonstrators who were opposing the arrest of military officer Captain Shegow Ahmed Ali.** The protesters were demanding the immediate release of Captain Ali, who had been arrested following a security operation in Mogadishu on Saturday. The shooting occurred in the Howlwadag neighbourhood and marked the second instance of security forces using live ammunition during protests, with the previous incident occurring in Mogadishu, Jowhar, and Beledweyne on Sunday, fortunately resulting in no casualties. Federal lawmaker Abdirahman Abdishakur Warsame criticized the government's use of violent means against protesters and stressed the need for a court order to arrest an army officer like Captain Ali. The arrest of Captain Ali and his armed men was carried out by Somali police forces, who accused them of disrupting the capital's security and engaging in confrontations with security personnel. A police spokesperson alleged the discovery of stolen mobile phones and counterfeit banknotes at Captain Ali's residence.

On August 21, 2023, **an incident took place at the Florenso intersection in Mogadishu involving two Somali soldiers.** One soldier inflicted injury upon another soldier. Prompt action was taken, as the injured individuals were swiftly transported to a nearby hospital for immediate medical attention.

August 21, 2023, **a large fire broke out at the KM4 bridge in Mogadishu, adjacent to the old vocational school in Buulo Tikniko.** The bridge was reportedly set ablaze by a group known as Cabtoy. Firefighters are working to extinguish the fire, although the fire brigade has not yet arrived. The area is engulfed in black smoke, raising concerns about the safety of nearby residents. Sadly, this incident has displaced six young individuals who heavily relied on social and government support. The fate of some individuals who might be trapped beneath the smoke remains unknown.

On August 21, 2023, **a white car was suspected of containing an explosive device near the National Hospital and was checked by EOD.** The authorities immediately closed the entire road leading to the hospital. The police bomb squad swiftly arrived at the scene to investigate the situation and ensure the area's safety.

On August 21, 2023, **efforts were initiated to mitigate a denial-of-service attack targeting the website of SJS Somalia.** The attackers utilised a proxy-provider to exploit thousands of IP addresses, leveraging them for their nefarious purposes. Notably, during March and April of the same year, a similar proxy service was employed to launch attacks on the website of Nacionaleks. The traffic patterns observed indicate that the proxy provider continues to allow such abusive activities. It is worth mentioning that attacks against the press through residential proxy providers have become increasingly common, with three different providers identified in the past year, all claiming to offer "ethical proxy services." A preliminary forensic report has been prepared, documenting the initial findings of this ongoing situation. For more information, interested parties can contact CPJAfrica, an organisation dedicated to promoting accountability and press freedom.

On August 21, 2023, **an IED explosion occurred in the city of Beelahaar, Jayren, causing significant damage.** The incident targeted the residence of Commander Sheegow Ahmed, who was attacked in his home during the early hours of the morning. The attack resulted in casualties and several individuals were injured. The motive behind the attack remains unclear, and investigations are underway to determine the responsible parties.

On August 21, 2023, **at the International Campus in Mogadishu, the Commander of the European Union Training Mission in Somalia (EUTM-Somalia) led the transfer of responsibility of the Force Protection Unit.** The event marked an important milestone as the 19th "Linci" Company concluded their tenure, and they were duly acknowledged and thanked for their diligent efforts. Simultaneously, the 1st "Cobra" Company was warmly wished good luck as they assumed the responsibilities of the Force Protection Unit.
